CONCEPT NOTE

There is no gainsaying the fact that an effective criminal justice system has been regarded as a quintessential prerequisite for the orderly functioning of a society. It's said that disputes and quarrels are as old as hills, and conflicts are second nature to human beings. But, the ancients had realized quite early on that unless the criminal elements were regulated and restrained, mankind would become extinct within no time.

Admittedly, criminal justice system has undergone sweeping changes since time immemorial. It has been influenced by various doctrines and dogmas. It has experienced a sense of déjà vu at times, and a feeling of legal demarche at other times. From being a strict deterrent system through reformative regime to victim compensation and plea bargaining, criminal justice system has come a long way.

India, under the British, was one of the early colonies that experimented with a codified criminal law, and saw a paradigm shift in streamlining of the same. Indian Penal Code, the substantive bedrock of the country's criminal justice regime, has strengthened the hands of the law enforcement since its inception. Several post-Constitution legislation have successfully reinforced the nuances of the adversarial system.

However, the last decade of the 20th century witnessed a socio-economic-cultural and technological revolution on an unprecedented scale, and it ushered in a tumultuous milieu all around. While it resulted in a new wave of unforeseen crimes such as money laundering, hate crimes, terrorism, etc., it also enabled the security forces to solve the crimes with the help of groundbreaking technology like DNA test, polygraph, ethical hacking and others. In between this scenario, the changing moral and ethical standards resulted in decriminalization of some socio-legal offences and criminalized some practices that were taken for granted. This period also saw rising crimes against women and children.

India is currently undergoing this phase wherein the new-gen offences and defenses are making the revisiting of the criminal justice system sine qua non. This seminar aims to appreciate the changing facets of criminal law in India in the backdrop of the global scenario with the following sub-themes.

SUBMISSION GUIDELINES

CONCEPT NOTE

The concept note shall be a minimum of 500 words and shall not exceed 1000 words, and must be accompanied by a cover page, containing the following details:

- Title of the Paper and Sub-Theme
- Name of the Author(s)
- Name of the Institution
- E-mail Address and Contact number
- Postal Address

Papers regarding the above mentioned sub-themes can be submitted for discussion at the seminar subject to the following submission guidelines.

PAPER

- **Following the presentation on the day of the seminar, the participants will be required to submit their full paper in line with the recommendations given by the Chair/ Moderators designated to the sub-themes of discussion.**
- **The Full paper has to be submitted within a maximum of 21 days, i.e. 14th of December, 2019.**
- **Subject to the decision of the University Editorial Committee, the final papers would be published.**
- **Co-authorship is permitted to a maximum of two authors. In case of co-authorship both the authors need to be physically present on the day of the seminar.**
- **No Proxy presentations will be allowed.**

FORMATTING REQUIREMENTS

- **The main text should be in Times New Roman with font size 12 and line spacing of 1.5. The footnotes should be in Times New Roman, font size 10 with spacing of 1.0.**
- **One-inch margins should be maintained on all four sides.**
- **Citation Style: Bluebook, 19th Edition/ 20th Edition.**
- **All Concept Note submissions are to be made in Microsoft Word (.doc) 2007/2010 format. Full paper has to be submitted in PDF.**
